Background

The Prison Rape Elimination Act (PREA) was passed by Congress and signed into law by President George W. Bush in 2003 to prevent, detect and respond to sexual abuse and sexual harassment that occurs in confinement settings. The law was expanded by President Barack Obama in 2012 via executive order to include all federal and Department of Defense correctional facilities. The National Prison Rape Elimination Commission developed national standards which apply to adult prisons and jails, juvenile facilities, lockups and community confinement facilities.

Air Force Corrections System Zero-Tolerance Policy

The Air Force Corrections System has zero tolerance towards all forms of sexual abuse and sexual harassment within its confinement facilities and is committed to preventing, detecting, and responding to such activity. Unit Commanders will immediately respond to allegations and refer sexual abuse or sexual harassment allegations for criminal investigation to the Air Force Office of Special Investigations (AFOSI). Disciplinary action will be pursued based upon the outcome of the investigations. Substantiated allegations will be referred for prosecution.

The Air Force has a designated agency-wide PREA Coordinator based at the Air Force Security Forces Center. All confinement facilities have a PREA Compliance Manager who follows the administrative lead of the PREA Coordinator in order to share information and efforts to ensure satisfactory inspection compliance. Air Force confinement facilities have established policy and guidance in accordance with the PREA standards.

PREA Allegations

There were a total of 3 PREA allegations within Air Force Level I Confinement Facilities in 2018. The following information details those allegations:

- In May 2018, the facility PREA Compliance Manager received a written sexual harassment allegation (inappropriate viewing of a sexual nature) from a male confinee within the facility. The confinee alleged that an opposite gender staff member was viewing the CCTV camera system while he was on suicide watch. An investigation was conducted which validated the facility was not following policy regarding opposite gender viewing but the confinees allegation of "viewing of a sexual nature" was unfounded. The facility initiated retraining for the entire staff on CCTV camera monitoring policies and took corrective actions regarding staffing when confinees are housed in special quarters.
- In August 2018, a pretrial detainee reported to a staff member that he was sexually harassed by a unit member performing guard duties. Specifically, the detainee reported the guard entered the shower area while he was taking a shower. An investigation was conducted where it was determined the guard did enter the shower area but it was in the performance of his duties. The detainee was spending an extended period of time in the shower and the guard was checking on the safety of the detainee and communicating for him to finish his shower/hygiene. The sexual harassment allegation was determined unsubstantiated.
- In September 2018, a confinee serving his sentence in a Naval Brig reported to the Brig's PREA Compliance Manager that while he was serving time in an Air Force facility, he was sexually harassed from March 2018 June 2018. The Navy PREA Compliance Manager notified the Air Force PREA Coordinator and Facility Head. The confinee alleges on various occasions, he was inappropriately viewed by 3 staff members while showering in the nude and performing bodily functions. The Facility Head (Defense Force Commander) ordered an investigation where the allegations could not be substanited.

Corrective Actions

The Air Force Corrections System collects data in accordance with Code of Federal Regulation (C.F.R.) 115.87 in order to assess and improve the effectiveness of its sexual abuse prevention, detection, and response policies, practices, and training. The information collected for this report will be used to identify problem areas and to take corrective action on an ongoing basis.
